### ADMINISTRATIVE LAW

The prime minister's decree n° 2-07-002 dated January 18<sup>th</sup> 2007, authorizing the national company Royal Air Maroc to create a subsidiary called « Atlas Multiservices » was published in the Bulletin Officiel dated 1<sup>st</sup> of February 2007.

The Royal Air Maroc can through this decree create a subsidiary pursuant to the article 8 of the law n° 39-89, promulgated by the Dahir n° 1-90-01 of April 11, 1990 and authorizing the transfer of public companies to the private sector

Indeed, article 8 of the abovementioned law, stipulates that, no creation of subsidiaries or sub-branches of any public company, under nullity, can be realized without an authorization given by decree taken on the proposition of the minister in charge of the transfers and preceded by an exposition of the motives.

The decree n° 2-07-002 of the 18<sup>th</sup> of January 2007 allows the RAM to create a subsidiary held 100% by the national company, a public company called « Atlas Multiservice », its capital is of 5 million dirham (5 000 000.00 dh) and it specializes in the intermediation and recruitment of temporary or permanent personnel and the sub-contracting in the field of general activities, as in cleaning of airplanes' cabins

The prime minister's decree, n° 2-07-010 of the 18<sup>th</sup> of January 2007 was published in the Bulletin Officiel of the 1<sup>st</sup> of February 2007. It authorizes l'Agence spéciale Tanger-Méditerranée S.A. (TMSA), to create a subsidiary called «Medhub S.A. » inside the free zone of Ksar Al Majaz. This, too, pursuant to article 8 of the law n°39-89, promulgated by the Dahir n° 1-90-01 of April 11, 1990 and authorizing the transfer of public companies to the private sector.

Since then, l'Agence spéciale Tanger-Méditerranée S.A. (TMSA) is authorized to create a subsidiary called «Medhub S.A. » with a capital of 10 million dirham, held totally by TMSA, which should operate inside the free zone of Ksar Al Majaz and which aims at exploiting the free zone's logistic, especially to commercialize the zone products to the clients and users.
